Agree – I'm reading through and finding several studies that also looked at ibuprofen and found no association. Lots of comments in Limitations of the individual studies about residual confounding and confounding by indication. Can't dismiss those concerns, but there appears to be some specificity of the association. (Can't get around the confounding by indication issue, although at least one study looked separately at specific indications and the association didn't go away.

Hmmm. We should continue by phone if there's more to discuss.

Enjoy Philadelphia. I've only seen the terra cotta worriers, myself.

Thanks. The weight of evidence is starting to feel heavy to me. We are talking with Rachel Ochs-Ross, the neurologist in CNS today. Originally it was to talk about biologic plausibility for benefit of acetaminophen, but now we've added the studies in prenatal exposure and neurodev outcome.

It looks like there are a bunch of papers from 2016 that we somehow missed. Many of them by Liew et al. Remember we contacted that group and they never got back to us. They did get busy though.
